### **MEET INFORMATION**

- The competition will be held under ASA Laws and ASA Technical Rules at the Pingles Pool, Avenue Road, Nuneaton CV11 4LX.
- 25metre 8 lane Pool with anti-turbulence lane ropes. Electronic timing with 8-line scoreboard is to be used in conjunction with a computerised result service. Results sheets will be available on-line after the event at [www.nun-bed-sc.co.uk](http://www.nun-bed-sc.co.uk)
- The Competition is open to registered swimmers as defined by ASA Laws: Age as at Midnight 5th December 2010.
- Individual awards for the first three places in each of the four Age Groups, 9/10yrs, 11/12 yrs, 13/14 yrs and 15 yrs/over, may be collected from the designated collection point.
- An award of £50 together with a trophy will be presented to the club with the highest overall points score at the end of the meet.
- All participants and spectators must observe the safety precautions in operation at the Pingles Pool and must be aware that the use of cameras and camcorders of any kind is not allowed within the building including mobile phones with in-built cameras.
- Neither Nuneaton & Bedworth Swimming Club nor Nuneaton & Bedworth Leisure Trust can be held responsible for loss or damage to spectators' or competitors' property. Competitors are advised to use the lockers in the changing rooms and not to leave belongings lying around unattended.
- All events are **HEAT DECLARED WINNER.**
- Over the top starts may be used to maintain the scheduled timing of events.
- It is the responsibility of Team Managers and Coaches to ensure that their competitors report to the Marshalling Stewards in time for the start of their race.
- The Café will be open for the sale of hot and cold refreshments during the meet.
- A swim shop will be available throughout the meet.
- NBSC reserve the right to use vacant slots within the programme for time-trials for its own swimmers.
- Anything not covered by these notes will be at the discretion of the promoters

## **ENTRY PROCEDURES**

- **Competitors ASA Registration Numbers and Date of Birth must be included on the Entry Form.**
- Entry times are to be converted to 25-m pool length and must be within the consideration times given. Heats will be seeded according to submitted entry times, with the final heat being spear-headed.
- NBSC reserves the right to refuse an entry or to close entries before the closing date should it prove necessary.
- No entry will be accepted without a fully completed entry form (or Club Consolidated Entry Form) – times must be submitted. Entries should be sent to:
